1. NAME OF THE SOCIETY

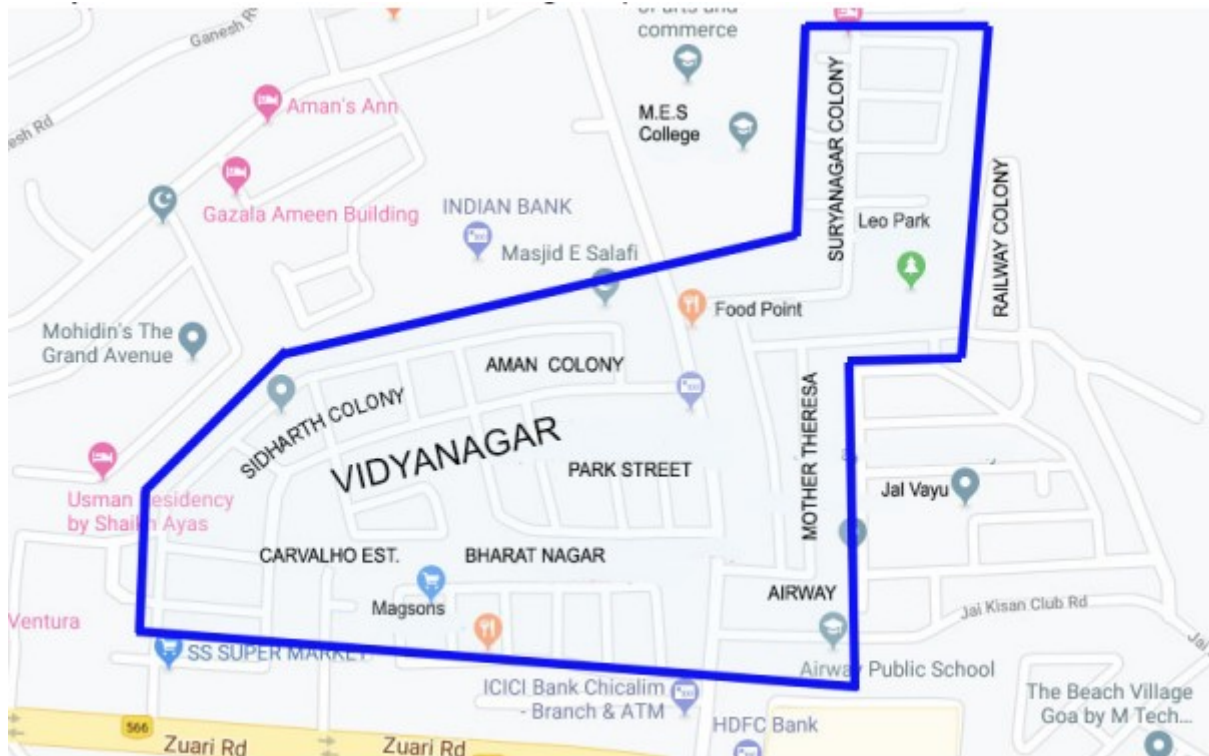
The name of the Society is 'VIDYANAGAR RESIDENTS WELFARE ASSOCIATION'

2. REGISTERED OFFICE

The Regd. office of the Society shall be situated at c/o Smt Shweta Hajare, 2nd Lane, Bharat Colony, Near M.E.S College, Zuari Nagar 403 726, South Goa.

3. AREA OF OPERATION

The Area of operation shall be Vidyanagar comprising of the 8 (eight) colonies as depicted below:



4. THE OBJECTS OF THE SOCIETY ARE:

- (a) To liaise between the residents and the elected authorities including the Panch, ZP member, MLA and Ministers for the benefit of residents of ward no 1, of the village Panchayat of Sancoale.
- (b) For organizing social, sporting and cultural activities.
- (c) To undertake minor maintenance work that does not exceed 15% of the total available funds per financial year.

No member of the Society shall have any personal claim on any movable or immovable properties of the Society or make any profits, whatsoever, by virtue of this membership.
